

# PRIVACY POLICY

(Information on the processing of personal data - Article 13 of EU Regulation 679/2016)

**Last updated: 18/10/2023**

Fugas S.p.A. informs the user that the data provided to the operator of the site when filling in the "contact form" (or email form) on the site itself, will be processed in compliance with the provisions of Legislative Decree 679/2016 - Personal Data Protection Code.

The contact form available on the site has the sole purpose of enabling visitors to contact our sales offices for purposes strictly related to the service.

This notice concerns the personal data submitted by the user visitor at the time of the filling in the contact form.

The data voluntarily provided via the form will be converted into an email that will be stored on our mail server.

This data will not be recorded on other media or devices, nor will other data resulting from the user's navigation on the site be recorded.

## **PURPOSE OF PERSONAL DATA PROCESSING**

The data sent via the contact form will be used for the sole purpose of being able to contact you back in order to process any requests contained in the message and/or consult your administrative/accounting documents and/or receive communications of a commercial/promotional nature.

## **NATURE OF THE DATA PROCESSED AND METHODS OF PROCESSING**

- The personal data processed will only be the common data strictly necessary and pertinent to the purposes set out in the previous point and/or for commercial/marketing purposes that the structure deems appropriate to initiate.
- The processing of the personal data provided is carried out by means of the operations or set of operations indicated in Art. 4 D. Lgs. 679/2016.
- The processing is carried out directly by the owner's organisation.

## **NATURE OF CONFERMENT AND CONSEQUENCES OF REFUSAL**

The user is in no way obliged to provide the site operator with the personal data requested in the contact form. The provision of data via the contact form is optional.

However, refusal to provide it for the purposes set out in Article 1 will result in the impossibility of contact our offices via the contact form provided on the site.

## **DATA CONTROLLER**

Personal data collected through the contact form will be sent by email to the data controller, Fugas S.p.A., Via Marchesina n. 42 20090 Trezzano s/n - Milano (Italy).

## **DURATION OF TREATMENT**

The data released by the user will be kept in our archives until the user requests deletion.

## **RIGHTS OF THE DATA SUBJECT**

The user may at any time exercise the rights attributed to him/her by Legislative Decree 679/2016, which we set out below, by making a special request via the contact form.

- The data subject has the right to obtain confirmation as to whether or not personal data concerning him or her exist, even if not yet registered, and their communication in intelligible form.
- The person concerned has the right to be informed:
  - the origin of personal data;
  - the purposes and modalities of the processing;
  - the logic applied in the event of processing carried out with the aid of instruments electronic;

- the identification details of the owner, the managers and the designated representative;
  - of the entities or categories of entity to whom or which the personal data may be communicated or who or which may become aware of them in their capacity as designated representative(s) in the territory of the State, data processor(s) or person(s) in charge of processing.
- The data subject has the right to obtain:
    - updating, rectification or, when interested, integration of the data;
    - the cancellation, transformation into anonymous form or blocking of data processed in breach of the law, including data whose storage is not necessary in relation to the purposes for which the data were collected or subsequently processed;
    - certification that the operations referred to in the two preceding points have been brought to the attention, also as regards their content, of those to whom the data have been communicated or disseminated, except where this proves impossible or involves a manifestly disproportionate effort compared with the right protected.
  - The data subject has the right to object, in whole or in part:
    - for legitimate reasons to the processing of personal data concerning him/her, as well as pertinent to the purpose of collection;
    - the processing of personal data concerning him/her for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
